# Extraction of Canadian Civil Vital Records

Canada's various Registrars of Vital Statistics, who have been granted authorization to record and deposit the official birth, marriage and death records for their respective regions, in the various provinces and territories of Canada vary from region to region with their rules for extraction of these records. These records for the period of restriction are only accessible by the Registrars' and, thus, for these periods we cannot search the registers ourselves.

Identified below is a chart of what civil vital records they hold and for what period. All these records can be certified or notarized for court purposes as requested. We will search and extract these records that are archived here within Canada while those for other countries will be charged out on a time and expense fee basis. Please consult this website for further details on the compensatory arrangement.

 $^{2}$ Many of the years of coverage are approximations as the early records were not consistently kept, nor survived, for many of these regions. Therefore, if a search is conducted and the record is still not found, those fees are still absorbed by the Registrar's and us.

<sup>3</sup>It is extremely important to remember that there is much Privacy restriction to access of identifying information held in Canada. Normally, these restrictions are as noted, however there are exceptions, particularly for executors and estate trustees dealing with probate of a client's estate. Please contact us directly for more specifics on those restrictions, and exceptions, if your needs are within the noted document restriction period range.

<sup>4</sup>The period allocated for receipt of the documents is to our office and are only estimates. The government departments' responsible are at present not committing sufficient time periods for the search and extraction of such documents and, thus, there may be significant delays. In most

<sup>5</sup>A service charge is added depending on the number of documents you order, any rush service, the taxes and the choice method of return delivery. Please be aware that there will be additional charges for any relevant government taxes (such as HST for Canadian residents), rush fees by the government agencies, and your chosen method of delivery to you at our cost - standard mail delivery or priority express post. Specific date and place of event must be known or the search may be more expensive, depending upon the number of years to be searched in the registers.

<sup>6</sup>Extraction of birth records, generally, are only available in the restrictive period to (1) the subject of the birth, or (2) their parents named on the record, or (3) their guardian with appropriate papers, or (4) a representative with written authorization of one of the other three parties noted herein. Should the subject be deceased the immediate next-of-kin, with proof of relationship, will be allowed access to this record. As agent for a client, we will require a signed & dated Letter of Authorization from one of these respective parties giving us permission to request the search and extraction of the original record on their behalf, along with any other documents of proof. It is important to remember that certified photocopies are very restricted and are usually only provided where evidence is given that they are needed for court purposes. In some cases, where you are denied access to the photocopy of the original record by the Registrar, you will provided with the 'short-form' version which includes, generally, only the name of the party(s), date and place of the event.

<sup>7</sup>Extraction of marriage records, generally, are only available in the restrictive period to (1) either party of the search, but both parties named, or (2) the children or the parents if both parties are deceased, or (3) a representative with written authorization of one of the two parties of the marriage. Should the subjects and the children be deceased the closest immediate next-of-kin, with proof of relationship, will be allowed access to this record. As agent for a client, we will require a signed & dated Letter of Authorization from one of these respective parties giving us permission to request the search and extraction of the original record on their behalf, along with any other documents of proof. It is important to remember that certified photocopies are very restricted and are usually only provided where evidence is given that they are needed for court purposes. In some cases, where you are denied access to the photocopy of the original record by the Registrar, you will provided with the 'short-form' version which includes, generally, only the name of the party(s), date and place of the event.

<sup>8</sup>Extraction of short-form death records, generally, are available to anyone with a valid reason, however normally only next-of-kin may obtain a certified photocopy (long form) of a death registration, along with any other documents of proof. It is important to remember that certified photocopies are very restricted and are usually only provided where evidence is given that they are needed for court purposes. In some cases, where you are denied access to the photocopy of the original record by the Registrar, you will provided with the 'short-form' version which includes, generally, only the name of the party(s), date and place of the event.

<sup>9</sup>It must be pointed out that some provinces and territories have a centralized system of registry and archival of probate and will records while others use a district approach. Depending on the region the search period may vary and may take longer if the district that the probate is registered in has to be determined.

<sup>10</sup>The information generally includes the adoption order, biological background information on the adoptee, and their original birth surname information. Other information may also be provided at the discretion of the Children and Youth Services. It is important that we will act as your agent in the obtaining of these records, though the agencies all have significant restrictions on who and how much information is released. Please contact us directly for more information on the information we will need to obtain from you in order to proceed with this search request.

<sup>11</sup>For a Divorce Certificate you will need to provide us with a copy of your Divorce Judgment or provide us with the full names of both spouses, year of divorce, court file number, and court registry location. If you do not have a copy of your Divorce Judgment, we can obtain this from the Courts for you. If your divorce was granted prior to 1986, you will receive a Certified Copy of a Decree Absolute. If you do not know all the details of your divorce, we will need to conduct a Canada wide search of the Central Registry of Divorce Proceedings which will involve an additional cost (\$50).

<sup>12</sup>Adoptions granted in Manitoba before 15<sup>th</sup> March 1999 prohibit the release of any identifying information without the consent of both parties. Adoptions granted in Manitoba after March 15, 1999 have a greater degree of openness. This allows eligible family members to obtain identifying information once all parties are 18 unless a disclosure veto has been filed with the Registry.

<sup>13</sup>Métis are persons of mixed blood - European/Aboriginal blood (Indian ancestry) – who are distinct from Indian, Dené, and Inuit, though someone who has genealogical ties to Aboriginal ancestry. A complex series of legislation, beginning with the Manitoba Act of 1870, provided for the settlement of claims arising from Aboriginal rights to land in western Canada. The Manitoba claims cover the period from 1870 to 1885. Those for the Northwest Territories, which included present-day Saskatchewan and Alberta, cover the period from 1885 to 1906. The federal government created a number of records in its day-to-day administration of the scrip that it issued to Métis residents of Manitoba and the former North-West Territories (as much of western Canada was known prior to the creation of modern-day Alberta, Saskatchewan, and the Northwest Territories in 1905). The records generally consist of the following: affidavits and applications, land and money scrip notes, scrip certificates, receipts, and a number of textual files consisting of letters and memoranda outlining government policies, rulings, and procedures. Often you will find claimants dates and places of birth, names of parents, names of spouses and names of children.

<sup>14</sup>Department of Indian Affairs of Canada hold records dating mainly from the late 1800s. The records are usually arranged by band, agency and district. Ancestral work can be conducted on these publicly available records with extension work done with the Federal government on later periods as required.
