Pinally, after more than four months, we can say that we have resolved this investigation.

Contrary to our usual reporting for you, we offer here only an abridgement of the search strategies and findings. However, if you feel that you need more information or documents, please don't hesitate to contact us further at that time.

This case certainly has had its problems almost from the beginning despite the fact there were lots of leads by which to trace this family. At every turn, it seemed we had poor or no locality information by which to trace the heirs. A couple of breaks in the past two weeks however, have allowed us to complete the investigation fully.

SUMMARY OF FINDINGS: Herein is a summary of our findings on this case:

Your Deceased, **Gordon Seymour Armstrong** (17th March 1906 at Toronto¹; d. 2000 in Moehto, Swaziland²) was the son of Wellington Willoughby Armstrong (b. circa 1862 at Halton,

ON³; d. 1919 at Toronto, ON⁴) and Margareta (Maggie) Seymour Pabst⁵ (circa 1874 at Council Bluffs, IA⁶; d. 19th March 1962 at Toronto, ON⁷) who were married on the 30th April 1894 in Victoria, BC.⁸ Gordon was one of three children to this couple, the other two siblings being - **Irving Wellington Armstrong** (b. 17th April 1899 in San Francisco, CA⁹; d. 13th January 1982 at Toronto, ON¹⁰), and **Arnold Willoughby Armstrong** (b. 13th June 1904 in Toronto¹¹, ON; d. 2nd January 1978 at Toronto, ON¹²).

Gordon, as you know, died unmarried and without issue as far as we both can determine.

The intestate's brother, Arnold Willoughby Armstrong (aka, Glenn Allan), was married early in adult life and does not appear to have divorced, though was openly gay by mid-life. His death has been found, and people that knew him have been spoken to in attempts to determine details on his marriage and children. These subjects knew of his marriage though indicated that he had no issue, which was confirmed by this death and probate record. We made no effort to seek out his marriage nor this wife's whereabouts as it would be irrelevant to this investigation.

The remaining sibling, Irving Wellington Armstrong, married a Helen Elizabeth Scopis (b. circa 1908 in Baltimore, MD¹³; d. 30th December 1995 at Georgetown, ON¹⁴) and produced two children. all of whom are now deceased - **Norman Wellington Armstrong** (b. 29th November 1943 in Toronto¹⁵, ON; d. 28th November 2006 at Toronto, ON¹⁶) and **Joan Elizabeth Armstrong-Jones** (b. 14th August 1937 at Toronto, ON¹⁷; d. 12th January 2005 at Montréal, QC¹⁸). Both children produced families of their own.

Norman Wellington Armstrong married a woman named 'Susan' who is still alive (living with her son for the moment) and together they produced two surviving children - **Terry Armstrong** (b. circa 1966 in Toronto) and **Kathleen Armstrong-Spiteri** (b. circa 1969 in Toronto).
